Overview

In March 2009 updated Worldspan Pricing displays will premier to encompass the addition of new pricing data and realign existing information for an easier to read screen display. The purpose for these changes is;

1. Realignment of existing data to create groupings for fare basis codes, taxes, and fee information by passenger type
2. New data elements for quick, at a glance ticket price and grand total summary information
3. Support of upcoming implementations; expansion for 99 Taxes, forthcoming ATPCO Ticketing fees (OB) Please note: introduction of 99 taxes and ATPCO (OB) Ticketing Fees will be handled with additional Product Advisories and Technical Specifications.

The upcoming Pricing Display changes will be reflected in the following fares products; Money Saver and Carrier Specific Fare Displays (4F), Itinerary Pricing (4P), Low Fare Finder (4PLF), Power Flight Search (\$P.1), Power Pricing (4PLI) and Power Shopper (\$P) and User Defined Itinerary Pricing (\$A).

Pricing Display Changes

Effective on March 4, 2009 changes will be made to pricing display as follows:

- A new pricing summary will replace the current pricing summary in all pricing displays. The pricing summary will indicate the ticket base, equivalent base (when applicable), tax total and total per PTC and for all PTCS.

Shopping Display Changes

When ticketing fees apply, changes will be made to shopping display as follows:

- A Ticketing fee summary will be displayed one line below the base, tax, total fare information.
- Ticketing Fee data will reflect sum of all applicable ticketing fees by pricing solution.
- The total fees will be shown along with the validating carrier code responsible for assessing these fees.
- A grand total will display next to the ticketing fee information.
- If account code or private fare information exists the ticketing fee will display above the account code or private fare information.
- Detailed ticketing fee information will be displayed in the pricing detail display (4PLI*Fn).
- Solutions will be sorted based on the Grand Total amount. If a Grand Total amount is not known because enough information was not provided to calculate all possible ticketing fee's or no ticketing fee's apply, the total Fare amount will be used as the sort criteria (instead of Grand total) for that solution. When ticketing fees do not apply to any pricing solution, all solutions will be sorted based on total fare (current logic).
- When multiple Passenger Type Codes (PTCs) are being priced, the total amount will appear one line below each pricing result. If the #/\$ option is used, the total for each PTC will be displayed.
- A new optional parameter will be introduced to request sort by total fare rather than by Grand total, regardless of whether a grand total exists or not. New optional parameter #TFT

All current error messages related to incorrectly entering a form of payment field in the PNR or ticketing entry will apply when a form of payment is specified in a pricing or shopping entry.

All currently accepted forms of payment (in the form of payment field of the PNR and ticketing entry) will be accepted. This includes accepting two forms of payment (for BSP subscribers).

Note: Two FOP will not be accepted in shopping entries (\$P, 4PLI)

When the new FOP optional parameter is used to specify FOP in the pricing entry, if a FOP is already stored in the PNR, calculation of ticketing fee's for display purposes will be based on the FOP specified in the pricing entry.

Current logic regarding overriding the FOP in the PNR when the FOP is specified in the ticketing entry or Pricing Instructions will not be modified.

Ticket Designator

Modification will be made so that when an account code is specified in the current account code option, the system will validate the specified account code against ticketing fees.

Account Code

Modification will be made so that when a ticket designator is specified in the current ticket designator option, the system will validate the specified ticket designator against ticketing fees.

Glossary

Term	Definition
S4	Ticketing Fee Service Fees record, Validating Carrier based, used to specify ticketing and/or booking fee charges to be collected.
Service Type Code	A code identifying the service for which a fee will be assessed. This code is made up of a generic "tax" (service) code and a more specific Sub-code to further define the service.
Significant/Primary Carrier	The marketing carrier on the governing/primary sector associated to the fare basis specified in this record.
Validate	Compare. When used in this document to describe how to process the data, the term "validate" means to compare. For example, "validate the data against the ticket being processed" means to compare the data against the ticket being processed.
Validating Carrier	The carrier whose ticket stock was used to issue the ticket (plating carrier). This carrier is commonly the holder of the money for the ticket.
